Q. Can the strat work plan be color-coded so that green is complete, yellow in progress, and red on hold.

A. Yes.

Q. Amount of grant money set aside is \$120,000 total. The High-performance grant is budgeted at \$40K. Is there still enough money in there for athletes to go internationally?

A. WSA could pull from other grants and applicants could apply for High performance grant as well.

Q. Wheelchair rugby chair budget?

A. Nothing in the budget for them. Would list them under “BTG equipment” if they were included in the budget. Will need to apply for grants. Cost will be high.

Q. Is this the year to let grant applicants know to apply for equipment or other things (as opposed to travel, etc.) because of COVID?

A. Yes. If applying for staff, we should see a job description.
